4. Terms Of The Event

1. Payment & Registration

Payments must be either made via wire transfer or PayPal account. In both cases the name of the participant must be explicitly mentioned to avoid complications. The registration is only complete when both the form has arrived and the amount in full has been accounted for.

2. Non-Attendance

Should the attendee not wish to attend the event a refund of the money will be granted. Cancellations of according hotel bookings with the Leela Palace in Bangalore have to be made different from the organizer of the event its self.
